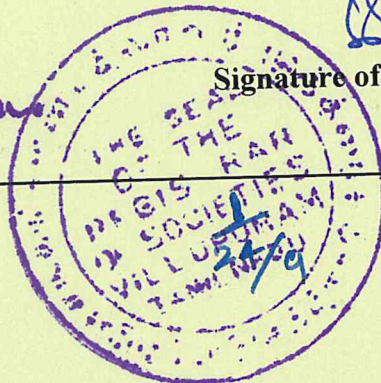

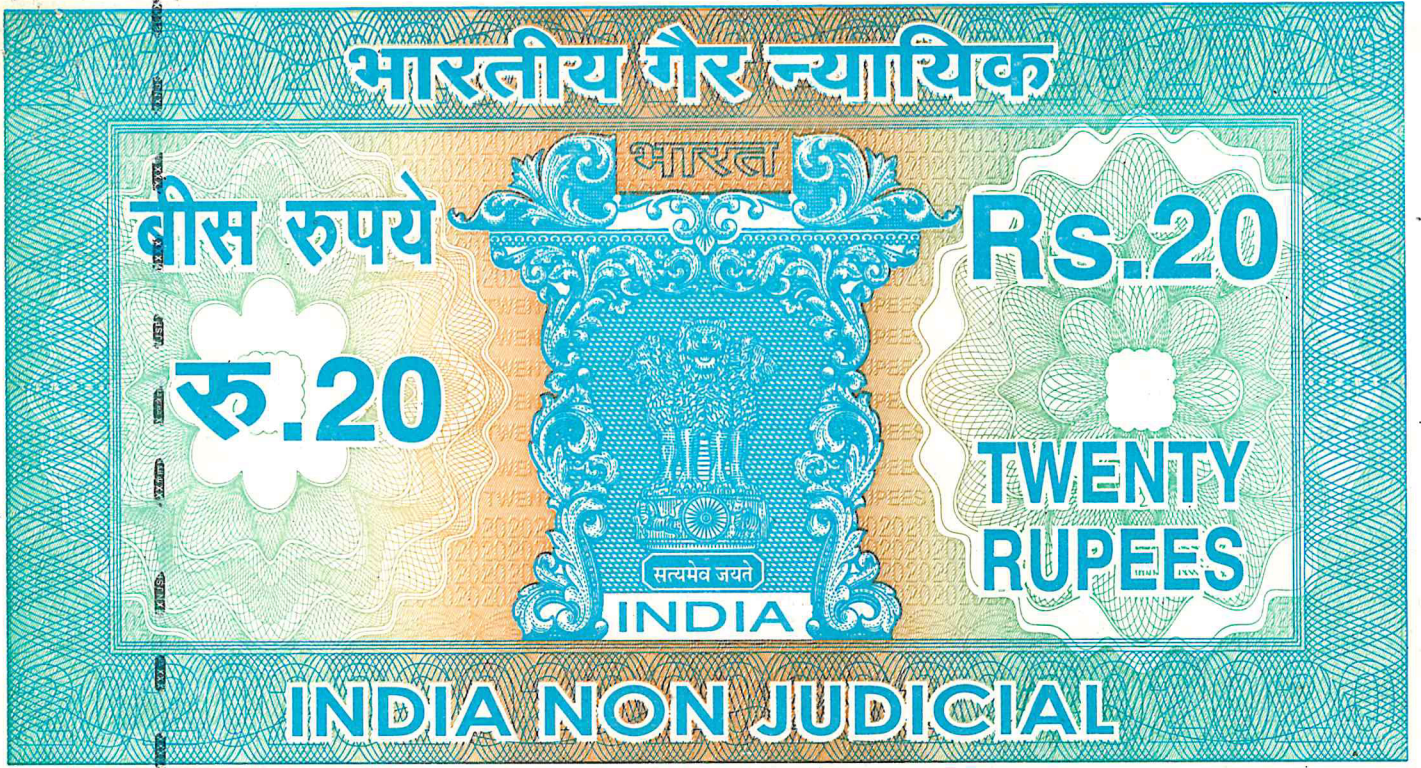

### MEMORANDUM OF ASSOCIATION

#### 1. Name of the society:

The name of the society is St. Joseph Educational Society-Villupuram

#### 2. Registered office:

Registered Office of the Society Shall be at No.486, East Pandy Road, Villupuram – 605 602 Tamil Nadu State and it may be shifted to such other place as the members of the society may decide upon from time to time depends upon the development of the activities of the Society.

#### 3. Objects:

- i. To promote and advance the cause of Education on the basis of National ideals and traditional spiritual culture.
- ii. To establish, maintain, manage, takeover or undertake management of Nursery Schools, Primary Schools, Middle Schools, High Schools, Anglo Indian Schools, Matriculation Schools, Higher Secondary Schools, Central Board Secondary Education (CBSE) Schools, Colleges, Computer education Centres, Tuition Centres, Tutorial Colleges, technical institutes, Hostels, Libraries and other Educational Institutions both residential and non-residential or any educational institution as notified by the Government from time to time for the advancement of knowledge in any subject or language without any intention of profit.
- iii. To establish, maintain, manage or to undertake management of Teachers Training School, Colleges, Centres, Universities, Deemed Universities to conduct Educational courses like D.TED., B.Ed., Physical Education, Medical Education, Hospitals, Para – Medical training Courses, Nurse Training Courses, Engineering Courses, Distance Educational Courses and other related educational courses.
- iv. To organize Entrance and coaching classes for all educational purposes.
- v. To conduct program to motivate the students for counseling, programmes, seminars and interviews.
- vi. To arrange and manage the training institutions in typing short hand, computer, fine arts, craft, internet browsing, music, painting, modeling, dancing, yoga, physical education, work skills and life skills at VPC (Vocation Programme Centre) and in the professional training subjects.

- vii. To conduct research in education and other disciplines on the different subjects relating to education.
- viii. To promote literacy, cultural and other social activities by awareness Programming, Adult education classes, Lectures, Essay competition Exhibition, Symposium Cultural programmes, Press conferences and Seminars.
- ix. To provide food, cloths, medicine and stationary, books transportation, libraries, , reading rooms, hostels boarding, playgrounds, swimming pools and other possible facilities to the students, teachers, wardens, clerks, servants, social workers, labours and those who are working in and for the society.
- x. To acquire, take over and hold all the existing movable and immovable property of any society Convent, Community College, Trust, in Tamilnadu, including all lands, building, structures, furniture, shed books, libraries, laboratories, crockery, vessels, sports articles prize and gift articles, statures, monuments, cash and bank balances, deposits, advances and all other assets and credits of whatever nature of kind, belonging to and hitherto held, maintained, due or owing to and managed by the society, subject-to any debts and liabilities as are now subsisting.
- xi. To promote and work for the advancement of education, learning, diffusion of knowledge, fine arts, charities and industrial and social welfare and for the purpose to establish, endow, conduct, maintain manage, administer and carryon educational, cultural, scientific, technical, industrial, social, agricultural and charitable institution, establishment, works and activities schools, colleges, hostels, boarding houses, home for children home for aged, home for disabled social institutions, clinics, dispensaries, hospitals, nursing homes, primary health centers, welfare centers, orphanages, balavadies, rescue homes and asylums for the poor, aged, destitute and handicapped, creches, work guides, convents, needle work, sewing and nursery schools, reading rooms, libraries, laboratories and recreation centres and the society is not limited to any particular sex, caste, Religion or community but shall be limited to its Territorial operation within India.
- xii. To acquire by purchase, transfer, gift, exchange, lease or otherwise accept properties, movable and immovable of any description and to receive any gift, donation, bequest, legacy, endowment or foundation for the purpose of the society.
- xiii. To enter into any agreement with any Government, municipal or local bodies, corporations, companies firms and individuals for the conduct and maintenance or concerning all or any institution, work or establishment above said.
- xiv. To improve, manage, develop, dispose off, sell, lease, let, sublet, under lease, mortgage or otherwise deal with all or any part of the properties of the society.
- xv. To invest and deal with the funds of the society not immediately required in such manner as may from time to time be determined and to open and operate banking accounts in the name of the society.

- xvi. To purchase, hire or acquire, take on lease, construct immovable or movable properties for the purpose of the society and to alter, add to, remove or demolish the same.
- xvii. To borrow or raise any money require for the purposes of the society upon such terms and such manner and on such securities as may be determined.
- xviii. To draw, make accept endorse or otherwise negotiate any promise note bill of exchange, cheque or otherwise negotiable or transferable instruments in connection with the business of the society.
- xix. To devote, apply or subscribe for any securities stocks, shares and debentures whether of governments, municipalities, local bodies, companies or corporation acquired, bequeathed or made over to the society.
- xx. To establish and support or aid in the establishment and support of associations, institutions, funds, trusts formed for the benefits of employees or ex-employees of the society or dependents or relatives of such persons and to grant pensions, allowances and gratuities.
- xxi. To concur with any other person, bodies corporate, companies, municipalities, local bodies and government in the establishment of any institution or establishment which the society is by virtue of this Memorandum of association competent to establish.
- xxii. To engage, employ or hire appropriate staff, workers, legal experts, auditors, attorneys, managers, agents and other professionals for the work and furtherance of the aims and objects of the society.
- xxiii. To receive corpus donations, voluntary donations, contributions, gifts, aids by cash or cheque or draft or bank account transfer from in land or foreign countries (FCRA or FEMA Contributions) or in kind to be utilised towards attainment of the objects of the society.
- xxiv. To receive loans or advances with or without security from any Bank, Corporation, Company Mutual Fund, individual person on such terms and conditions beneficial to society and the funds to be utilised towards attainment of the object of the society.
- xxv. To grant donations, contributions, endowments, loans, aid payments, gift of amount in cash or by cheque or draft or bank on-line transfers or by way of presenting articles or in kind to any charitable society, trust, institution, temple, chapel, church, mosque for the purpose of relief of poor, educational, medical relief, for advancement of any other object of general public utility without any discrimination as to caste, creed, gender, community or religion.
- xxvi. To utilize or apply or spend all the incomes, earnings, movable or immovable properties of the society towards the promotion or attainment of its aims and above objectives set forth in this and no portion thereof shall be payable or transferred directly or indirectly by way of dividends, bonus profit or in any manner, whatsoever through them. No members of the society shall have any personal claim on any movable or immovable properties of the society or make any profit, whatsoever by virtue of the membership.
- xxvii. To exercise control over any group of societies/trusts/educational institutions for the purpose of society and controlled units for this purpose the society may receive or give money for specific or general purpose at regular or irregular intervals.

### Bye – Laws, Rules and regulations

**1. Name of the society:**

The name of the society is “St. Joseph Educational society - Villupuram”

**2. Address of the Registered office:**

The address of the Registered office of the society is as follows:

St. Joseph Educational Society - Villupuram  
No.486, East Pondy Road,  
Villupuram- 605 602.

**3. Objects of the society:**

The society is established for the purposes expressed in the Memorandum of Association.

**4. Membership:**

The membership of the society is open to any person who has attained the age of maturity and fulfils the terms and conditions of the society but subject to the approval of the executive Committee of the society. The Executive Committee shall have the power to accept a person as a member or reject the person at their discretion without assigning any reason of their so doing.

**5. Membership Fee**

The Entrance fee Rs.100/- and the Annual Subscription Rs.50/- shall be in force unless otherwise revised by the Executive Committee of the society.

**6. Rights & Privileges of the Member:**

All and every member of the society:

- have rights to visit the office of the society and seek the registers and minute books
- shall be entitled to participate in meetings, cultural and educational functions and other lawful gatherings called or arranged by the society and to cast their vote in General Body meetings.

**7. Duties of the Members:**

All and every members of the society shall:

- a. attend the General Body Meetings regularly.
- b. elect the members of the executive Committee.
- c. give the necessary information to the society pertaining to any matter which is necessary to be known by the society.
- d. not indulge in activities which are prejudicial to the objects and the regulations of the society.

**8. Termination or Cessation of Members:**

The Executive Committee of the society shall have the powers to expel or terminate a member or members or remove the name of the member or members, from the membership of the society on the following grounds:

- a. on death
- b. on written resignation
- c. if found to be involved in any anti/social activities,
- d. if adjudged by any court of Law to be criminal offender.
- e. if found guilty by means of anti propaganda of the objective of the society.
- f. if fails to pay the subscription for two years.
- g. if disregards the rules and regulations or disobey the decisions of the Executive Committee.

However the aggrieved member any appeal in writing to the Executive committee within 15days of receipt of communication of termination. The appeal shall be considered by the executive Committee whose decision shall be final.

**9. Executive Committee:**

- a. STRENGTH: The executive Committee shall consist of seven members.
- b. TERM: The term of the executive committee members will be three years. They shall be eligible to be re-elected.
- c. COMPOSITION: The composition of the Executive Committee shall be as under.  
One President  
One Treasurer and  
Four Executive Members
- d. MEETING: The Executive Committee shall meet as many times as necessary to transact business but it shall be at least once in three months. If possible, the date and time of the next meeting will be decided at the previous meeting.
- e. NOTICE: Minimum fourteen days notice shall be required for the executive Committee meetings of the society but urgent executive Committee meetings can be called by Twenty Four hour notice.
- f. Quorum: Quorum of every Executive Committee meeting shall be the presence of one-third of the total strength of the executive Committee.

**10. Functions & Powers of the Executive Committee:**

- a. The Executive Committee shall be responsible for the management and administration of all affairs of the society and is also authorized to appoint any office bearer of Executive member to look after any particular activity.
- b. The Executive Committee makes amend or repeal bye-laws and Rules & Regulations relating to the administration and management of the society and conduct of its own meetings.

**11. Powers and Duties:**

**PRESIDENT**

- ❖ The president shall preside over meetings of the Executive Committee and the General Body.
- ❖ The President shall be the executive and administrative head of the society.
- ❖ The president shall have power to execute all deeds agreements contracts and legal documents for and on behalf of the society and shall be custodian of all such documents.
- ❖ The president shall be responsible to implement the aims and objects of the society and to carry on the policy decisions of the General Body and the Executive Committee.

**SECRETARY**

- The secretary shall record the minutes of the General Body and the Executive Committee meetings and shall maintain all the records of the society.
- The Secretary is directly responsible for all the works entrusted and should report to the Executive Committee on the progress of the works.
- The secretary shall prepare and file the following records to the registrar every year after the Annual General Meeting.

- Membership statement
- Declarations
- Auditors Report and Financial Statements

**TREASURER**

- All funds of the society shall remain under the care and management of Treasurer.
- The Treasurer shall keep the receipts and payments accounts, income and expenses accounts and the assets and liabilities position of the society.
- The Treasurer shall prepare the annual financial statement and submit the annual audited accounts to the Executive Committee and the General Body.
- Then Treasurer, On Consultation with the President prepare the annual budget for approval of the Executive Committee.

**12. Filling up of Casual Vacancies:**

- a. Any casual vacancy amongst the executive Committee shall be filled by the resolution passed by the executive Committee. Such appointments shall be confirmed by the General Body in its next General Body Meeting after such filling up.

- b. If, in case at any time the total strength of the members of the society falls below seven the society shall continue its activities with the lesser members by passing resolution in its Executive Committee. The Executive Committee shall admit new members in order to bring the strength to seven. The administration shall be confirmed by the General Body in its next meeting after such admission.

**13. Registers to be maintained:**

The following registers to be maintained;

- a. Cash Book
- b. Leger
- c. Register of Members
- d. Receipt Books
- e. Voucher Files
- f. Bank Pass book or statement of Bank account.

**14. Financial Year Period:**

The financial Year Period of the society shall be from first day of April to thirty first day of March ever year.

**15. Finance:**

All the incomes, earnings, movable or immovable properties of the society shall be solely utilized and applied towards the promotion or attainments of its aims and objects of the society set forth in the Memorandum of Association and no portion thereof shall be payable or transferred directly or indirectly by way of salary, commission dividends, bonus, profit or in any manner, whatsoever, to the present or past members of the society. No member of society shall have any personal claim on any movable or immovable properties of the society or make any profit whatsoever, by virtue of the membership. Provided the nothing herein contained shall prevent the payment in good faith of remuneration to any officers or teachers or wardens or servants of the society or to any member thereof in return for any services actually rendered.

**16. Banking Operation:**

The Treasurer of the society has empowered to hold a hand cash to a maximum of Rupees Ten Thousand at any time and the balance of funds shall be deposited in saving bank account or current account or fixed deposit of any scheduled bank or banks. The banking accounts of the society shall be operated by joint signatures of the Treasurer and either president or Secretary.

**17. Audit**

The accounts of the society shall be audited by a qualified chartered Accountant every year.

**18. General Body Meetings;**

- a. All the members of the society will constitute the general body of the society
- b. An ordinary General Body Meeting shall be held once in a year between the month of April to September. The time and place shall be fixed by the Executive committee.
- c. Quorum of the general Body Meeting shall be 2/3(two third) of the total members.
- d. Minimum 15 days notice shall be given for a General Body Meeting by local delivery or by the post or by circulation to the members. The notice shall be a fixed in the notice board.
- e. The General Body shall receive the auditor's report financial statements, annual reports on the activities of the society and discuss the general work and policy of the society.
- f. The General Body shall elect the members of the executive Committee and approve or confirm the vacancies filled up.

**19. Amendments:**

i) Any amendment in the Memorandum of Association or in the constitution of the society may done at any time at the General Body Meeting or at a special Meeting convened for the purpose by a special resolution passed by a 2/3 (two third) majority of the members present at the meeting. However the power to effect amendment to the memorandum of association does not extent to altering the basic character of the objects of the trust. Notice of any proposal or amendments or additions shall be circulated to all the members of the society along with the notice of the meeting at which the proposal are to be considered.

ii) Any amendment to the memorandum of association or in the constitution of the society, if grant of registration under the provision of section 12AA (b) of the Income Tax Act 1961 obtained for the society, shall be carried out only with the approval of the commissioner of Income Tax having jurisdiction to the society.

**20. Dissolution:**

If it any time it is found that no longer feasible or convenient to conduct the society, special resolution shall be passed for dissolution of the society. On dissolution, all the properties and funds of the society with the liabilities, if any shall be transferred and made over to any other Society or Institution having the same objects as above or more or less similar objects and upon dissolution the members of the society have no rights or claims on the properties of the society.

**21. Resolution by circulation:**

If a proposal calls for an urgent or immediate decision, but a meeting cannot be conveniently held, the president or vice president may forwards the proposal to the members of the Executive committee by circulation, and on acceptance by all or the majority of the, it will be an valid as a resolution passed at a meeting of the Executive committee and recorded as such in the Minutes Book of the Meetings of the Executive Committee.

22. **Property:**

All properties of the society, movable, or immovable and all assets shall vest in the Governing Body, and all documents affecting or relating to such property, shall stand in the name of the society.

23. **General:**

- The society shall not carry on any activity with the intention of earning profit.
- The legal provisions in regards to the investments of the funds of the society and the provisions of the section 13(1) (d) read with section 11(5) applicable to the charitable society under the income tax Act 1961 shall be complied with.
- The society shall not carry out any activity outside India.
- The benefits of the society are open to all irrespective of Caste, religion, Community, gender or religion.

24. **Declaration:**

All the things which are not specifically provided in these Bye-laws Rules and regulations, the provisions of the Tamil Nadu Society's Registration Act 1975 will apply.
